Updates (cont.)

- **Form Report Grader:** Dave Parsons has completed the form report graders training and will start grading reports.
- **AMA Waiver Exam:** 11 assessors took the exam, 7 passed and 4 failed.
- **Rule Change:** The deadline to submit a comment for proposed changes expired on April 29, 2020. We received 9 responses, and no requests for hearings. The Board's attorney contacted the Governor's office to get the final rule draft approved. We received approval from the Governor's office on May 18, 2020 to proceed with the rule changes. The rule change documents will be sent to the Office of Administrative Hearings for review this week. The judge will have 14 days to review the rule for legality.
- **Complaint Summary:** Since March 2020, the Department of Revenue received one new homestead complaint. The only open complaints are homestead related and a responsibility of the associated counties. At this time all investigations have been closed, and no new cases have been opened.
- **MAAO Curriculum & Assessor Standards Committee Update by Gary Amundson:** The committee is moving forward with publishing the AMA standards, then will start working on the CMA and SAMA standards.

Approved Continuing Education Hours Requests

- **2019 IAAO Annual Conference on Assessment Administration:** Ann Miller requested CEH's for this conference, which was held on September 8-11, 2019, in Niagara Falls, Ontario Canada sponsored by IAAO. The board's continuing education committee approved this request for 14.5 hours of continuing education. The sessions approved were those that Ann Miller attended.
- **The Fundamentals of Appraising Luxury Homes:** Rolf Erickson requested the board review this online course sponsored by McKissock for continuing education. The board's continuing education committee approved this request for 4 hours of continuing education.

- **Policy Changes after Rule Changes are Adopted:** The board discussed the following policy changes.
 - Remove the Elective and 15-Hour USPAP course from the Designations and Fee Appraiser.
 - Remove the Elective course from the Real Estate Degree.
 - Remove AMA from the Assessment Administration course.
 - Remove the Assessment Administration course and College Courses as an elective.
 - Remove the two 15-hour courses to be used as an elective.

Joy Kanne made a motion to align the board policies with these changes once the rules are adopted. Jane Grossinger seconded the motion. The motion carried.

Discussion Items (cont.)

- **Continuing Education Course (CEH) List:** Board members will be auditing the existing board approved online courses to ensure they are providing quality assessment related education.
- **Licensure Requirements & Rules Changes:** Board members will research the existing board approved licensure courses to see which 15-hour courses will meet the property specific course requirement for the AMA license. They will also research the options for the Management and Leadership courses required for the SAMA license.

The chairperson set the next meeting date as Tuesday, July 14, 2020 at the St. Michael City Center in St. Michael, MN at 8:30 am.
