Agenda for the March 10, 2020 meeting was reviewed. Reed Heidelberg moved to approve the amended agenda. Charlie Blekre seconded the motion. The motion carried.

Updates (cont.)

- **AMA Deadline:** Andrea Fish & Bobbi Spencer met with the PTCO's on January 23, 2020 and discussed the progress of the Assessor AMA Deadline report. There are 251 active licensed assessors that are required to get their AMA by July 1, 2022. 156 reported that they will be applying for their AMA; 8 assessors will be taking the waiver exam, and 87 reported no. We reminded the PTCO's that the deadline to take the AMA Waiver exam is April 30, 2020.
- **SAMA Communication:** Revised the SAMA letter & email communication to those applying for the SAMA license.
- **Ethics Letters:** 42 letters were sent via email on 1/23/2020 to the assessors that have not taken ethics in the current 4-year cycle. The employers were copied on the email.
- **Rule Changes:** On February 5, 2020, the rule documents were sent to Minnesota Management & Budget (MMB) and the Governor's office for review and approval. Both MMB and the Governor's office approved the proposed rule changes. We are aiming for March 23, 2020 to publish in the State Register.
- **Complaint Summary:** Since January 2020, the Department of Revenue received 2 complaints, the only open complaints are homestead related and a responsibility of the associated counties. Since the last update, the department has not opened any new investigations and have closed the only open investigation.
- **MAAO Course Surveys:** Jane Grossinger reviewed the surveys and found nothing concerning about how the courses are being taught.
- **MAAO Curriculum & Assessor Standards Committee Update by Gary Amundson:** Gary Amundson reported that the Assessment Administration course will be changing in the next 3 years, and may become an MAAO course. There is a new 2-day residential course that will roll out this year. The curriculum committee is moving ahead with completing the other AMA licensure standards.

Appointments with the Board

MAAO Course Update: Emily Squyres, MAAO Education Coordinator, provided a course registration and results report for past courses from 2018 thru 2019 and course registrations for 2020 for the board to review. Emily reported that MAAO will continue co-sponsoring with Appraisal Institute for the Basic Appraisal Principles and Basic Appraisal Procedures courses in 2020. Mike Wacker, the Chair of the Education Steering Committee, reported that the feedback on locations was concerning, so MAAO will be looking at properties with guestrooms and conference space in the same location. MAAO will be rewriting the Basic Income course and create an

Advanced Income course for the future. Emily updated the board on MAAO's 90-day re-exam policy, MAAO will be adding "within one year but highly recommends to do the re-exam within 90 days" to their current policy.

Discussion Items

- **Reinstatement Policy:** Andrea Fish made a motion to remove the 15-hour USPAP requirement and the Ethics and PACE requirements, except for AMA's & SAMA's, starting on July 1, 2020 when the new 4-year cycle begins. Reed Heidelberger seconded the motion. The motion carried.
- **Licensure courses and challenging an exam:** The board decided there was no need to add a policy for challenging a licensure course exam.
- **Trainee License:** The board reviewed Rule 1950.1020 Licensure and it was decided that no policy was needed.
- **Basic Appraisal Procedures from McKissock:** After a comparison of this course with the AMA Standards, Joy Kanne feels that it really hit all the areas of appraisal theory in our standards. This class would set a student up wonderfully for the MAAO Mass Appraisal course, an excellent introduction to appraisal.

The chairperson set the next meeting date as Tuesday, May 19, 2020 at the St. Cloud Holiday Inn in St. Cloud, MN at 8:30 am.

Reed Heidelberger made a motion to pay the expenses for the meeting. Charlie Blekre seconded the motion. The motion carried.
