Board of Assessors Update

Printing Your Assessors License

With the [new licensing system](#) there is a new way of receiving your FY 2019 Assessors License. If your name is on the FY 2019 Minnesota Licensed Assessors lists your FY 2019 assessors license is ready to print. You can view and print the license from your personal account on the Assessor Licensing System. You will need to log in to your account, select the Records tab then select the View & Print License link.

Continuing Education Hours Increase

Once the State Board of Assessors rule changes are adopted, the continuing education hours requirement will increase. CMAs and CMASs will go from 40 to 50 hours and AMAs & SAMAs will go from 50 to 60 hours for the current 4-year cycle (7/1/2016 – 6/30/2020).
