Region 8's total estimated market value for taxes payable in 2016 was \$20,883,285,768. Agricultural and rural vacant land, both used as a homestead and not used as a homestead, accounted for 56% of the market value in the region. Polk County had the highest estimated market value of the counties in the region, with 28% of the total market value within the region. Four counties Norman, Marshall, Beltrami, and Polk) together account of 66% of the market value in the region.

#### **Submitting Course Completion Certificates:**

All course completion certificates must be submitted on the <u>Assessor Licensing System</u>. Log into your personal assessors account, select the "Submit Education" tab, then "Submit Proof of Education." There is a section on the form where you will be required to upload the course completion certificate. After the request is submitted, it will be approved directly on your account.

## **Legislative Committee Updates**

The 2020 regular session of the Minnesota Legislature is scheduled to convene on Tuesday, February 11 and will adjourn on May 18. We currently have a working group of assessors and county administrators looking into legislative solutions to address the dark store issue. State assessed tax court appeals and decisions continue to be a concern for taxing jurisdictions and MAAO is involved in discussions on the issue.
