### State Board of Assessors - FY 2019 Assessor's License

Time is running out so make sure to renew and pay for your assessors license by **June 30, 2018.** 

Licenses issued for renewal based on the receipt of applications/fees postmarked on or before June 30th will have an effective date of July 1st.

Licenses issued for renewal based on the receipt of applications/fees postmarked July 1st or after are effective as of the postmark or online received date
