What is the Dan Franklin Scholarship?

In 1998 the Dan Franklin Memorial Scholarship Fund was established is remember Dan Franklin, who was Wilkin County Assessor and Grant County Assessor during his 30 plus years in assessing and served as MAAO President in 1963. Dan Franklin was an education leader for Assessors during his time, being described by some as the "grandfather" of our education system by spearing heading many of the beginning educational opportunities for assessors across the state.

The scholarship is awarded annually to one student attending a Minnesota University working towards a degree in Real Estate, preferably with an emphasis in Appraisal. Several of Dan Franklin winners have gone on to be County Assessors themselves including Tina Diedrich-Von Eschen, Kanabec County Assessor (2000 winner) and Karl Lindquist, Grant County Assessor (2007 winner).
